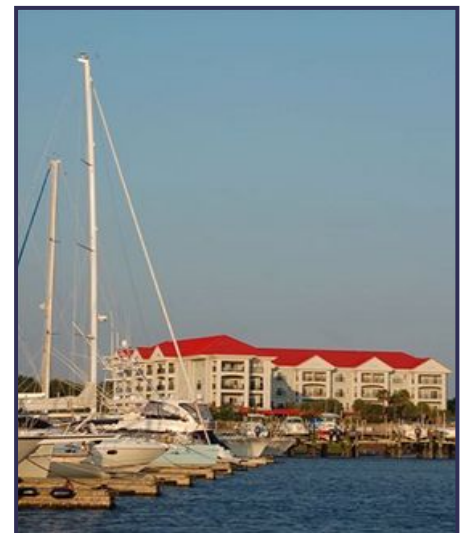

## GA/SC MOVERS ASSOCIATIONS

### 2010 Convention Golf Tournament - Rules of Play

*Monday, September 13, 2010*

1) The USGA Rules of Play will govern all competition, except for local rules of play and those regarding the scramble team format.

2) On every hole, each member of the team may hit a tee shot. All members of the team may then hit from that position. This procedure is repeated until the ball is holed out. Each team member may place the ball within one (1) club length of the selected shot, no nearer the hole. If the shot selected is played from a hazard, bunker, rough (intermediate or regular), fairway or fringe of the green, the ball must be played from within one (1) club length of the shot selected, no nearer the hole, and must remain in the hazard, bunker, rough (intermediate or regular), fairway or fringe of the green. When putting, once the ball is holed out, no further strokes count. The team is cautioned not to make "tap in" putts until all members have had the opportunity to attempt the team's original putt. The original putt may be moved a maximum of two inches (2") from the mark, no closer to the hole.

3) A team member, including the one who hit the original tee shot, may hit the next shot. If players purchased mulligans (maximum of two per player), we ask that mulligan shots be used in a timely manner. No mulligans are permitted for main Hole In One Prizes. Only the first shot taken by each contestant is eligible to win the Hole In One Prize offered or Closest to the Pin.

4) **No mulligans may be used on the green for putting.** Mulligans can only be used on the tee box, fairway or rough. Mulligans may be purchased at the registration desk for \$5.00 each with a maximum of 2 per player.

5) Team members may stand behind one another to help determine the line of a shot or putt.

6) **Tee off** - Men are to tee off from the white tees. Women are to tee off from the ladies tees.

7) **Scoring:**

- A team's Net score is calculated by subtracting its Scramble handicap from its gross score.
- No team shall have more than one (1) bogey per nine.
- In the event of a tie, a blind draw will take place to determine what hole will begin comparison scores. Holes will then be compared in reverse order.
